Tip Sheet -MBARA Piggyback Tournament

When and Where:

- Thursday, July 24, 2025
 - Captain's Meeting: 6:00 Mexico Beach Boat Ramp
- Friday, July 25, 2025
 - MBARA Captain's Party – 6-8pm Food, Door Prizes, Raffle for those entering the MBARA Tournament
- Tournament fishing and Weigh-Ins
 - Tournament fishing begins after the Captain's Meeting on Thursday, July 24th
 - The ASWSC fishing days are Friday July 25 and Saturday July 26.
 - Weigh-in time will be 5:00 pm Friday and Saturday. No exceptions will be made on timing.
 - If you have no fish to weigh, you are still expected to check in with the tournament director to ensure you have returned safely – If not, the US Coast Guard will be called.
- Saturday July 26, 2025
 - Awards Social 7:00 PM at Mexico Beach Boat Ramp
- We'll do the club awards and social in conjunction with the MBARA event. They will have some chairs and shade, and we'll bring some extra ones too, but to be safe bring your own. The Club will supply:
 - Awards
 - Beer, water and soda
 - A Hot Dog Buffet

Other Tournament Information:

- This tournament will piggyback on the MBARA Kingfish Tournament and be run as a "tournament within a tournament." You are encouraged to join the MBARA Kingfish Tournament to support a great cause. Please understand and follow the MBARA Kingfish Tournament rules for Saturday fishing: lines in time for each division, weigh in time, etc.
- Physical **Weight In** – We will follow the ASWSC Traditional/Offshore Points Matrix for scoring.
- **Kingfish Bonus** – Each kingfish weighed during the two-day tournament will earn 100 team bonus points. Kingfish bonus points will only be awarded to the team and not apply to Angler of the Year points.
- **Entry Fees** - ASWSC Members are encouraged to enter both tournaments but must enter the ASWSC Tournament at a minimum. Pricing has been reduced to \$50/boat for this tournament to help offset the cost of the MBARA Kingfish Tournament Entry. Trophies, awards, and meals provided by ASWSC will be reduced accordingly and members are encouraged to take advantage of the benefits of the MBARA Kingfish Tournament.
- **Pre-Fishing** and other **social** activities will be encouraged. Please let the tournament director know of your plans if you will be down a few days early to fish and/or hang out in the Mexico Beach area and we will try to coordinate ad-hoc fishing and/or other recreational activities.
- **Dockage, Trailer Parking, Ramp**– If you are planning to keep your boat in the water, you can leave your trailer at the Mexico beach boat ramp.
 - Dockage - \$2.00/day/foot or \$11/week/foot
 - Boat Ramp Usage \$25/day , cleaning station access included
