### "Bay City Brawl" - June 3-6, 2026 (3 Day)

#### When:

- Planned Captain's Meeting: Wednesday June 3, 5:00 pm at The Lay House - Bay City Lodge
- Tournament fishing: June 4,5,6 (Thursday, Friday, Saturday) - 3 Day Format
- Planned Weigh-in location - Bay City Lodge Docks in person
- **All boats must be back to docks at 6:00 pm Thursday and Friday, and 5:00 pm on Saturday to qualify for that day's weigh-in.** If staying off premises, captains must check in by the designated time.
- Weigh in times 6:30-7:00pm Thursday, Friday; 5:30-6:00 pm Saturday
- Awards Banquet: Food Truck from "Tamara's On the Go" - Fish Fry (same as last year). Saturday June 6, at 7:45 pm. Location: The Lay House - Bay City Lodge. Please bring your own folding chair.

#### Other Tournament Information:

- Scoring - per the official ASWSC Offshore Points Matrix . Nearshore will utilize Nearshore Matrix via photo submission.
- **Rules** - Traditional/Offshore and Nearshore Tournaments Points Matrix, Tournament Rules, Nearshore Rules Addendum and guideline documents available on the [ASWSC Tournaments](#) Web Page.
- **Inclement Weather** - Per club rules, in the event of a Small Craft Warning, tournament fishing may be suspended or restricted. Any fish caught outside of allowed parameters will not be eligible for weigh-in or scoring.

**Bay City Lodge/850-653-9294** - Cabins and Motel style rooms available. **Call for availability and make reservations ASAP.** Restaurant normally serves breakfast and dinner (seasonal)

**Sportsman's Lodge/850-670-8423** - In Eastpoint FL, rates include boat dockage but it is very shallow and the docks are a step down from Bay City. In and out with a 21' boat was no problem. There is a free city ramp 1 block away for smaller boats. The ramp may be tight for larger boats.

**Best Western /850-653-9131** Smoking & non-smoking rooms are available. Free hot breakfast buffet 6:30 - 9:30

**Water Street Hotel and Marina/850-653-3700** - Marina on-site can fit vessels up to 60 ft

#### Dockage / Ramps:

##### **Bay City Lodge / 850-653-9294**

- Slips- no charge but available on first come-daily basis, no slip reservation
- Non-ethanol fuel available on site (will see if they will keep pumps on till 7:00pm)
- Boat Ramp can launch vessels to 25 feet
- Trailer parking is available but limited

**Scipio Creek Marina / 850-653-8030:** An option for boats too big for Bay City's ramp.

**Battery Park (Ten Foot Hole) Public Ramp:** location link <https://goo.gl/maps/WLdU2bucNTp>

- can accommodate vessels up to 40 ft.
- 4 double-wide concrete ramps with ample parking.
- \$10.00 launch fee (Link: Battery Park Marina/Ramp)
- Located below the Hwy 98 bridge on the Apalachicola River, Bay Ave & Water Street (less than 1 mi. east of Scipio Creek Marina)

### **Bait and Tackle Shops:**

#### **Bay City Lodge / 850-653-9294 / 1000 Bay City Rd, Apalachicola, FL**

- Frozen bait including Squid, Chum, Sardines, Cigar Minnows (call in advance for availability)
- Live shrimp, subject to seasonal availability
- Terminal tackle and fishing lures
- Small supply of marine supplies available

#### **Bluewater Outriggers / 877-216-9600 / 121 U.S. 98, Port St. Joe, FL 32456**

- Frozen bait including Squid, Ballyhoo, Chum, Sardines, Cigar Minnows, Silversides
- Wide selection of terminal tackle, fishing gear, boating accessories, clothing, and fishing lures

#### **Fisherman's Choice / 850-670-8808 / 330 U.S. Hwy 98, Eastpoint FL**

- (Next to NAPA Auto Parts, 8 mi. from Apalachicola)
- Dead bait including Squid, Ballyhoo, Chum, Sardines, Cigar Minnows, silversides
- Light selection of lures and terminal tackle

#### **Live Pinfish: Sullivan's Live Pinfish/ 850-643-6965 / Boat will be at the Govt. Cut in the AM**

- Pre-Order Fish – Call a few days ahead if possible. He may be at the Captains Meeting to take orders
- Generally, he supplies live Pinfish
- Meet him at his boat in the cut on the way out to fish
- He is presently trying to sell the business, but says on Facebook he will be working till it sells

#### **Tips for catching your own bait**

- Try the old St. George Bridge <https://goo.gl/maps/yZCPsJrptSy>
- Sabiki rigs tipped with shrimp (optional) work well for pinfish, sand perch, etc.
- **Do not** try to use the water at Bay City to keep your bait, it is too fresh. Use seawater and an aerator to keep bait fresh

**Note: I will try to arrange for Fish Cleaning to be available at Bay City for those who do not want to clean their catch. He will usually clean your catch that night, bag them by species, and put on ice in the icehouse. I believe he charges by the pound. Details at the Captain's meeting.**
